

Camper Air Transportation Information Sunday July 11th through Saturday July 17th

For campers who are flying alone to either Detroit Metropolitan Airport (DTW) or Flint Bishop Airport (FNT), Michigan Youth Bridge Inc Camp provides round-trip airport pick-up/drop-off on arrival and departure days **for \$40**. This service is ONLY for campers who are flying alone or with another camper.

Please review the following information:

- Traveling campers <u>must</u> have a fully CHARGED cell phone and charger.
- It's your responsibility to review the airlines "Unaccompanied Minor" policy and let us know what steps need to be taken on our end if your child is traveling as or considered an "Unaccompanied Minor." This policy varies for each airline.
- On Arrival Day (Sunday), please schedule a flight that arrives at
 - Detroit Metropolitan International Airport between 10:30 2:30 pm
 - Flint Bishop between 12:00 and 3:00 CST.
 - If this is not possible, please contact us to see if we can work out alternate arrangements.
- On Departure Day (the following Saturday), please schedule a flight that departs between <u>4:00 – 7:30pm</u> CST. If this is not possible, please contact us to see if we can work out alternate arrangements.
- When you receive your flight information, please forward us a copy via email. We will acknowledge receipt of same.
- We will send air travelers an email approximately one week prior to Michigan Youth Bridge Inc Camp with information on what to do upon arrival at the airport as well as the names/contact information of MYB personnel who will be meeting them at the airport. This should also include a photograph. Hopefully, the youth can be met at the gate.
- This following application form must be completed and provided to us no later than <u>June 20th</u>. The air travel fee <u>must</u> accompany the form.
