The event saw a **net loss** of \$459.00.

In an effort to make this event more efficient and, perhaps, profitable. The 2019 GNT's will be held on one day only: Sunday, April 14, 2019, at the Bridge Connection in Southfield. A motion to make this

change from a two day event to a one day event was made by Paul Pomeroy and seconded by Richard Temkin. It passed unanimously.
