We understand that we may withdraw from this event prior to commencement of play. If we notify the Event Coordinator of our withdrawal on or before September 14, 2006, we will receive a full refund of our entry less a \$5.00 administrative fee. If we notify the Event Coordinator of our withdrawal on September 15, 2006 or September 16, 2006, we will receive a refund of our entry less a 25% administrative fee. If we fail to appear for the event or if we withdraw prior to gametime on September 17, 2006, we will forfeit our entire entry fee.

We understand that, in the event either member of this partnership is found to be ineligible to participate in the event after commencement of play, we will forfeit our entire entry fee.
